The work is in the Department of Economic Development, Planning, and Tourism, and involves providing assistance to Cattaraugus County and its communities helping to identify and meet their development needs in the areas of economic, industrial, and community development. Duties are performed under general supervision with allowance made for the use of independent judgement and critical thinking in carrying out the details of the work. Supervision may be exercised over subordinate clerical personnel. A Development Specialist does related work as required.

#### Minimum Qualifications:

Graduation from high school or possession of a high school equivalency diploma and either:

- A. Possession of a Bachelor's Degree in Planning, Business or Public Administration, Economics, Accounting, Finance, Marketing, Public Relations, Journalism, Communications, English, Travel and Tourism, or closely related field;

OR

- B. Possession of an Associate Degree in Planning, Business or Public Administration, Economics, Accounting, Finance, Marketing, Public Relations, Journalism, Communications, English, Travel and Tourism, or closely related field AND two (2) years of experience in planning, economic development, business or public administration, accounting or finance, marketing, public relations, journalism, or a position regularly involving narrative writing and editing responsibilities;

OR

- C. Four (4) years of experience in planning, economic development, business or public administration, accounting or finance, marketing, public relations, journalism, or a position regularly involving narrative writing and editing responsibilities;

OR

- D. An equivalent combination of training and experience as defined by the limits of A), B), and C).

NOTE: Your degree must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. A list of acceptable companies who provide this service can be found on the New York State Civil Service website. You must pay the required evaluation fee.
